The candidates are also advised to go through the eligibility conditions as mentioned in the ASRB's Notification for ARS-2016 Examination [No. 1(9)/2016-Exam.II dated 21.03.2017]. If the candidates do not possess the required relevant documents/ certificates in support of their eligibility, they shall not be allowed to attend the viva-voce.
