### Limited Departmental Competitive Examination-2016 for Recruitment to the Post of Assistant at ICAR Headquarters

A Limited Departmental Competitive Examination for drawing up a select panel for filling up 06 (Six) vacant posts (UR-02; SC-02, ST-02) of Assistants in the PB-2 – Rs. 9,300 – 34,800 + Grade pay of Rs.4,600/- falling under “Limited Departmental Quota” at the ICAR Headquarters will be held by the Agricultural Scientists Recruitment Board (ASRB) at New Delhi on 07 & 08 February, 2017 in accordance with the rules issued by the Indian Council of Agricultural Research (ICAR). The date for the examination is tentative and liable to change. The exact date, time and venue of the examination will be intimated to the candidates in their Admission Certificates. The number of posts is tentative and liable to change. The venue of the written examination will be NRL Auditorium, NRL Building, IARI, Pusa, New Delhi – 110012.

2. The ASRB will have the discretion to fix qualifying marks in any or all the subject of the examination. However, with the approval of competent authority, it has been decided that the cut-off marks for qualifying the written examination will be 40% and 30% for UR (General) and SC/ST candidates respectively for this examination.

3. The examination will be confined to UDCs at the ICAR Hqrs. having at least 6 (six) years regular service in the grade as on 01-07-2016.

4. The rules, scheme of examination, syllabi and application form for the examination are also available in ICAR website [www.icar.org.in](http://www.icar.org.in) and ASRB website [www.asrb.org.in](http://www.asrb.org.in).

5. Interested persons who are eligible to appear in the aforesaid examination may send their applications in the prescribed application forms (proforma enclosed) through proper channel so as to reach the undersigned latest by 15<sup>th</sup> January, 2017.

Applications received after the due date under any circumstances is liable to be rejected.

### RULES

The rules for the Limited Departmental Competitive Examination to be held by the ASRB for drawing up a select panel for filling up posts of Assistants in PB-2 of Rs. 9300-34800/- with grade pay of Rs. 4600/- falling under Limited Departmental Examination quota in the ICAR are published for general information.

1. The number of persons to be selected for inclusion in the select list will be specified in the Notice issued by the ASRB. Reservation shall be made for candidate belonging to SC and ST as per Govt. of India orders.
2. The examination will be conducted by the ASRB in the manner prescribed in the Appendix to these rules.

The date on which and the place at which the examination will be held shall be decided by the ASRB.

3. The examination will be confined to UDCs in PB-1 of Rs. 5200-20200 with grade pay of Rs. 2400 at the ICAR Hqrs. having at least 6 years regular service in the grade as on 1<sup>st</sup> January, if the examination is notified in the first half of the calendar year and 1<sup>st</sup> July, if the examination is notified in the second half of the calendar year at the respective Institute/ Headquarters.
4. The decision of the ASRB as to the eligibility or otherwise of a candidate for admission to the examination shall be final.
5. No candidate will be admitted to the examination unless he holds a certificate of admission from the ASRB.
6. A candidate who is declared by the ASRB to be guilty of:-
  - i). Obtaining support for his candidature by any means, or
  - ii). Impersonating, or
  - iii). procuring impersonation by any person, or
  - iv). submitting fabricated document or documents which have been tampered with, or
  - v). Making statements which are incorrect or false or suppressing material information, or
